Background

Established in 2006 to help offset the Commonwealth's unfunded superannuation liabilities the Future Fund is one of Australia's largest investors and is also responsible for investing the assets of the Higher Education Endowment Fund.

In October 2008 the Future Fund released its annual report for the 2007-08 financial year (available at www.futurefund.gov.au) and provided an update on the development of the organisation and the direction of its investment program.

This event will provide further insight into the investment thinking and priorities of the Future Fund and is an opportunity for industry participants to hear from members of the Future Fund's management team.
